



Account Aggregation Request Form - MidAmerican Energy

_____ (hereinafter "Building Owner") has agreed to participate in Energize Des Moines, the energy efficiency challenge for large buildings. The challenge requires owners and managers of buildings above 25,000 square feet to benchmark and report annual energy and water use. Building Owner has requested assistance from MidAmerican Energy (hereinafter "MidAmerican") in gathering aggregated data for building(s) participating in the energy challenge. MidAmerican is willing to provide such assistance, subject to the following conditions:

- 1) MidAmerican will not provide data that is identifiable to any specific MidAmerican customer in the building other than the Building Owner. If a multi-tenant building has fewer than five (5) metered account holders that are different than the Building Owner, then Building Owner is required to obtain an executed release from each account holder using copies of the "Account Holder Release Form" and provide the releases to MidAmerican before this request form will be considered to be complete.
- 2) The information is provided "As Is." While MidAmerican will endeavor to provide accurate data based on the information provided, it makes no representations or warranties that the data will be error-free or complete.
- 3) If an Agent Company is identified below, Building Owner hereby authorizes MidAmerican to provide the necessary information for all Building Owner accounts to the Agent Company.
- 4) Building Owner shall indemnify, defend and hold harmless MidAmerican and its officers, employees and agents from all claims, liabilities and damages incurred by MidAmerican as a result of the assistance it provides under this agreement, except to the extent caused by the gross negligence or willful misconduct of MidAmerican.
- 5) Incomplete or inaccurate request forms cannot be processed. MidAmerican requires 30 days to process a complete request form before aggregation data can be provided.
